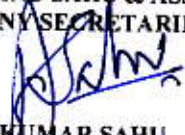

Dear Sir

The Board of Directors of your Company at its meeting held on **February 17th, 2016** has appointed me as a Scrutinizer for conducting the Postal Ballot Voting process including voting by electronic means.

The Management of the Company is responsible to ensure compliance with the requirements of the relevant provisions of:

- (a) The Companies Act, 2013 and the Rules made thereunder; and
- (b) The Listing Agreement(s) with the Stock Exchange, relating to Postal Ballot voting including voting by electronic means.

My responsibility as a scrutinizer is restricted to make a Scrutinizer's report of the votes casted by the members for the resolution contained in the Notice dated **February 17th, 2016**, based on the reports generated from the e-voting system provided by **CDSL**. Only **28** Shareholders had opted for e-voting till the time fixed for closing of the voting process i.e. closing of workings hours on **March 25th, 2016**.

I submit my report as under:

1. The Company has completed on **February, 25th 2016** the dispatch of all Postal Ballot forms along with postage prepaid envelopes to its members whose name(s) appeared on the Register of Members as on February 12th, 2016.
2. After the time fixed for closing of the Remote e-voting on March 25th, 2016, a final electronic report of the Remote e-voting was generated by me by accessing the data available to me from the website <https://evotingindia.com> of Central Depository Services (India) Limited. Data regarding the Votes was diligently scrutinized.
3. All Physical Postal Ballots received till the time fixed for closing of the Postal Ballot on March 25th, 2016 were diligently scrutinized and reconciled with the records maintained by the

Company through Link InTime India Private Limited, the Registrar and Share Transfer Agents of the Company and the authorizations lodged with the Company.

4. Particulars of all the Postal Ballot forms received from the Members have been entered in a register separately maintained for the purpose.
5. The Postal Ballot forms were kept under safe custody in a separate ballot box before commencing the scrutiny of such Postal Ballot forms.
6. All Postal Ballot forms received up to the closing of working hours on March 25th, 2016 the last date and time fixed by the Company for receipt of the forms were considered for my scrutiny.
7. No envelopes containing Postal Ballot forms were received after the closing of working hours on March 25th, 2016.
8. The Votes were unblocked on March 26th, 2016 in presence of two witnesses Miss Sanchieta Chartterjee residing at 90, Shyama Prasad Nagar, Sikola Bhata, Durg (C.G.) and Miss Priyanka Athwani residing at Lakhe Nagar, Behind Kanhaiya Cloth Store, Raipur (C.G.), who are not in the employment of the Company.

A summary of the Postal Ballot voting including voting by electronic means in respect of passing of the resolution contained in the Notice dated **February 17th, 2016** through Postal Ballot is enclosed as **Annexure-I** to this report.


I have handed over the Postal Ballot forms and other related papers/registers and records for safe custody to the Chairman to supervene the Postal Ballot process.

After the aforesaid scrutiny of the Postal Ballot Forms and taking into account the Remote e-Voting results, I report that the Special Resolution as contained in the said Notice have been passed with requisite majority as required under the provisions of Companies Act, 2013.
